

CHAPTER PROXY FORM

This form is for active chapters who are unable to attend Plenary. An active chapter unable to attend Plenary may assign, by proxy, its voting power on policy, procedural, and electoral matters to an attending chapter, **provided the following requirements are met of both the chapter receiving and the chapter assigning the proxy:**

1. The chapters must be active chapters of NBLSA located within the same Region;
2. The chapter assigning the voting power by proxy must complete this form; **and**
3. The chapter receiving the proxy must, itself, have voting delegates registered for Convention and physically attend Plenary.

No chapter may receive more than two proxies. The chapter receiving and exercising the voting power by proxy shall follow all voting instructions provided by the assigning chapter. In the absence of instructions, the receiving chapter must vote in a manner reasonably construed to be in the best interest of the assigning chapter.

To help facilitate the certification process, this form should be sent to the Director of Membership AND the appropriate Parliamentarian at least thirty (30) days prior to Plenary. Otherwise, chapters must request an extension. Your Director of Membership and Parliamentarian can be contacted at:
